### Suspension of the Sunday driving ban for trucks – overview of German regions' decrees

Suspension of the truck driving ban on Sundays and public holidays in the German federal states; all regulations refer to commercial resp. own account transport of goods with trucks of over 7.5 t MPW or trucks with trailers – as of 23.03.2020):

Bavaria	general exemption permit with no differentiation according to the type of goods	with immediate effect and until 29.03.2020, 22:00 h
Berlin	dry products and medical supply, including empty runs	with immediate effect and until 01.06.2020
<i>Brandenburg</i>	<i>general exemption permit with no differentiation according to the type of goods</i>	<i>with immediate effect and until 26.04.2020</i>
Bremen	dry products destined for retail, including empty runs	with immediate effect and until 30.05.2020
Hamburg	general suspension with no differentiation according to the type of goods, including empty runs <i>The wording speaks of Sunday exemptions only – holidays not included</i>	with immediate effect and until 16.04.2020.2020
Hesse	Transports of dry products destined for retail	with immediate effect and until 30.06.2020
Mecklenburg-Western Pomerania	Transports of foodstuff, hygiene products, medical supply	with immediate effect and until 16.09.2020

<i>North Rhine-Westphalia</i>	<i>general exemption permit with no differentiation according to the type of goods, including empty runs</i>	<i>with immediate effect and until 30.05.2020</i>
Rhineland-Palatine	general exemption permit with no differentiation according to the type of goods, including empty runs	with immediate effect and until 26.04.2020, 22:00 h
Saarland	general exemption permit for dry goods. Accompanying documents must indicate places of departure and destination as well as transported goods	with immediate effect and until further notice
Saxony	dry products, medical supply, including empty runs. Documentation needed indicating places of departure and destination as well as transported goods	with immediate effect and until 05.04.2020
<i>Saxony-Anhalt</i>	<i>dry products, hygiene products, medical supply, including empty runs. During July and August, no need for an exemption from the additional summer restrictions (§ 4 Ferienreiseverordnung); Documentation needed indicating places of departure and destination as well as transported goods</i>	<i>with immediate effect and until 31.08.2020</i>
<i>Schleswig-Holstein</i>	<i>general exemption permit with no differentiation according to the type of goods</i>	<i>with immediate effect and until 26.04.2020</i>
Thuringia	Transports of foodstuff, hygiene products, medical supply, including empty runs	with immediate effect and up to and including 01.06.2020
